Overdraft Protection

For qualified members, if there are insufficient funds in your checking account, our standard overdraft practice (Courtesy Pay Service) is to cover checks, ACHs and automatic bill payments. These funds may be transferred from other XCEL FCU Deposit and Line of Credit accounts in your name. If you do not have a Line of Credit and would like to apply for one, complete the Line of Credit section. Federal regulations limit electronic withdrawals and transfers from a Savings account to six each month.

XCEL FCU will not authorize and pay overdrafts for ATM transactions and Everyday Debit Card Transactions unless you opt-in below:

You must bring your account balance positive within 30 days from the date of your first overdraft occurrence. These terms and conditions will be disclosed in accordance with applicable state and federal laws.

Statutory Lien: If you are in default on any financial obligation to XCEL Federal Credit Union, federal law gives us the right to apply the balance of share and dividends in your account(s) at the time of default to satisfy the obligation. Once you are in default, we may exercise the right without further notice to you. I/We acknowledge and pledge to XCEL Federal Credit Union a statutory lien in my/our shares and dividends on deposits in all joint and individual accounts and any monies held by XCEL Federal Credit Union now and in the future, to the extent of any loan made and any charges payable. The statutory lien does not apply to shares in any Individual Retirement Account.

Federal law requires all financial institutions to obtain, verify, and record information that identifies each person who opens an account, including joint account owners and authorized signers. Therefore, when you open an account, we will ask for your name, address, date of birth, and other information that will allow us to identify you. We will ask to see your driver's license or other identifying documents.
